## **PUBLIC HEARING JUNE 26, 2025**

The Florida Department of Transportation (FDOT), District One, invites you to the public hearing for the State Road (SR) 72 (Clark Road) Project Development & Environment (PD&E) Study on Thursday, June 26, 2025.

This hearing is being conducted to present the preferred alternative and all analysis to date, as well as to give interested persons an opportunity to express their views concerning the location, conceptual design, and social, economic, and environmental effects of the proposed improvements. You can participate live online or in-person. The information presented during either format will be the same and all attendees will have opportunity to comment.

In accordance with Section 4(f) of the Department of Transportation Act of 1966, FDOT is seeking comments concerning the effects of the project on the activities, features, and attributes of Twin Lakes Park.

**Project Overview** 

FDOT, District One, began a PD&E study in March 2022 along SR 72 (Clark Road) from east of I-75 to Lorraine Road in Sarasota County. The purpose of the project is to identify and evaluate potential improvements to this 3.4-mile segment of SR 72. These improvements are intended to improve capacity to accommodate future travel demand projected as a result of area-wide population and employment growth. Other goals include enhancing safety conditions and accommodating bicycle and pedestrian activity.

SR 72 plays an important role in the transportation network as it facilitates east-west movement within Sarasota County for both local and regional traffic,



including commercial traffic. SR 72 from east of I-75 to Lorraine Road is currently a two-lane undivided roadway with intermittent right-turn and left-turn lanes. Improvements may include widening to a four-lane divided roadway as well as bicycle and pedestrian accommodations such as a shared-use path.
