The Florida Department of Transportation (FDOT), District One, will present the proposed improvements to Harborview Road from Melbourne Street to I-75 in Charlotte County.

This public information workshop gives interested people the opportunity to express their views about the Project Development and Environment (PD&E) study for the proposed widening of Harborview Road.


The workshop will be an open house format with a continuous video presentation throughout the workshop to provide you with a complete overview of the project. Project staff also will be available to informally discuss the project, receive your input and answer your questions.

Project Overview

FDOT is studying the proposed widening of Harborview Road from two to four lanes. Widening the road will improve connectivity between US 41 and Interstate 75, enhance safety along the corridor, and improve emergency evacuation. The proposed widening of Harborview Road includes four 11-foot travel lanes, curb and gutter, and a 30-foot grass median. Six-foot sidewalks and seven-foot buffered bicycle lanes will accommodate pedestrian and bicycle traffic along the corridor. A total of 114 feet of right-of-way is needed to accommodate the proposed improvements. The proposed posted speed for this urban typical section is 40 mph.

Funding for the design phase is included in fiscal year 2020 of the FDOT's Adopted Five-Year Work Program. Right-of-way acquisition is currently included in fiscal year 2023. There is currently no funding for the construction phase of this project.

The environmental review, consultation, and other actions required by applicable federal environmental laws for this project are being, or have been, carried out by FDOT pursuant to 23 U.S.C. §327 and a Memorandum of Understanding dated December 14, 2016 and executed by the Federal Highway Administration and FDOT.
