

**II. PROJECT BACKGROUND**

In April 2016, the Polk Transportation Planning Organization (TPO) adopted a resolution to support the Nature Coast to Peace River Greenway Trail Corridor between Bartow and Tallahassee. With this resolution, the TPO requested the Florida Department of Environmental Protection’s Greenway and Trails Council to consider the Trail Corridor as a high priority for future SUN Trail funding. The Old Dixie Trail is the segment that would connect the trailheads of Auburndale-TECO Trail and Haines City Trail, for a distance of approximately 12 miles. The Old Dixie Trail Project Development and Environment Study (PD&E) is intended to assist FDOT to determine the location and conceptual design of the Old Dixie Trail (ODT). The Old Dixie Trail PD&E is intended to provide regional connectivity that will offer recreational and economic development benefits. The ODT also offers connections to the Lake Alfred Trail and Chain of Lakes Trail, as well as other planned future trails. Figure 1 outlines the project location and proposed alternatives.

Public involvement activities previously occurred during the ODT Feasibility Study, as listed in Figure 2 - The Old Dixie Trail Feasibility Study Public Outreach Activity Schedule. During the Feasibility Study, some individuals requested to receive email updates regarding the project during the PD&E phase. Their contact information is included in Appendix A. Stakeholder interviews and follow up from public meetings took place in 2017. Comments and information from these discussions are included in Appendix B, Feasibility Study Comments and Correspondence. Additionally, in July 2019, meetings took place with representatives from the cities of Auburndale, Lake Alfred, Winter Haven and Haines City, as well as Polk County and the Polk Transportation Planning Organization (TPO) to consider the six trail alternatives. Using feedback from these meetings, two of the six alternatives were selected for further analysis.

### III. PROJECT GOALS

The purpose of the project is to address an existing gap in the regional trail network between the communities of Auburndale and Haines City in Polk County, Florida. Other goals of the project are to 1) provide a safe, viable, nonmotorized travel option for commuters and recreational trail users to access area destinations and 2) support quality of life and economic objectives of the surrounding area.

The study is divided into two phases:

- Phase 1 – Feasibility
  - Collect and analyze existing conditions data
  - Examine engineering factors (safety, right-of-way, etc.) and environmental factors (natural and human built environment)
  - Identify opportunities and physical constraints
  - Conduct stakeholder interviews to understand community goals and needs
  - Analyze trail segments
- Phase 2 – Project Development & Environment (PD&E) Study
  - Identify and define alternatives that meet and/or address the study goals and objectives
  - Conduct environmental analyses required under NEPA
  - Conduct stakeholder interviews to understand community goals and needs

This Public Involvement Plan (PIP) is intended to address those activities associated with the study. Addendums to this PIP will be included as necessary. The general study area encompasses Auburndale to Haines City, including Lake Alfred and Winter Haven.

In addition to working with the media, a number of different notification techniques will be used throughout the project development process. A brief description of these techniques is provided below. Please see Figure 3 for and outline of the Old Dixie Trail PD&E Study Public Outreach Activity Schedule.

**Letters/Newsletters:** Invitational and informational letters and newsletters will be distributed to elected and appointed officials, property owners/tenants, business owners/operators, and interested parties as feasible, after Notice to Proceed, prior to the workshop, prior to the public hearing and after Location and Design Concept Acceptance (LDCA). Notices will be hand delivered to residences and business located directly on the two project corridors as deemed necessary by the FDOT.

**News/Press Releases:** News/press releases will be submitted to the FDOT seven days prior to each public meeting and the public hearing.

**Public Notices/Display Ads:** Public advertisement will consist of a display advertisement published once in the area newspaper with the largest circulation prior to the public meeting, twice to announce the public hearing, and once to announce federal LDCA at the end of the study.

**Public Announcements:** In order to distribute PD&E phase information, fliers will be made available to organizations such as neighborhood/civic groups, the FDOT, and Polk County, to publish in existing newsletters and websites. Any such correspondence will be coordinated through the District's Communications Office.

**Direct Mail List for Public Meetings/Hearings:** The following will be contacted by direct mail in order to obtain input throughout the project development process and/or in order to provide project information:

- Those whose property lies, in whole or part, within at least 300 feet on either side of the centerline of each project alternative (Section 339.155, FS), as well as local citizens who may be affected by the construction of this project. This portion of the mailing list will be based on the Polk County Property Appraiser's tax rolls.
- Local elected and appointed public officials or individuals who request to be placed on the mailing list for this project.
- Public and private groups, organization, and agencies, or businesses that request to be placed on the mailing list for this project.

**Project Website:** In addition to the public workshops, an additional method for public participation in this project will be through a project website. The website will provide current project information to elected officials, agencies, and the public. The website will include a facts page, information about the study such as start date, estimated completion date, a project map, and project manager contact information. The website will also have a description and explanation of PD&E Study process. Project documents will be available for download and a project schedule will be posted. There will also be a Contact Us page for site viewers to email project staff to provide comment(s) on the project or to submit a question. **Community Group Meetings:**

The team will coordinate with the Cities of Auburndale, Haines City, Lake Alfred, and Winter Haven to identify leaders in the neighborhood communities and will meet with the groups/homeowner associations in similar fashion to the stakeholder interviews. Coordination will take place with neighborhoods such as Lake Henry Estates (Sweetwater East Investment Community).

**Public Information Meetings:** Public workshops will be one of the most important facets for the project’s success. Because the five alternatives from the Feasibility Study have been narrowed to two alternatives for the PD&E Study, individual mailing lists along the two corridors have been developed. Additionally, project notification for the first public workshop will also be through other means such as press releases, the Florida Administrative Register, newspaper advertisements, website links, and project contact list notifications. A public information meeting in the form of a public workshop for the PD&E phase is tentatively planned for Fall 2020.

**Public Hearing:** A formal public hearing, as required by federal regulations and state law, will be held.

**VII. COORDINATION WITH POLK COUNTY AND THE CITIES OF AUBURNDALE, HAINES CITY, LAKE ALFRED, AND WINTER HAVEN**

Regular coordination is planned with all agencies with jurisdictional responsibilities. Included in the coordination are unscheduled meetings, and ongoing discussions with agency representatives. As part of the coordination, copies of maps depicting all alignment and design concepts under consideration, along with draft copies of any engineering and environmental study documentation, will be furnished to the county and city for review and comment prior to the scheduled public hearing.

**VIII. PUBLIC HEARING**

In compliance with the Project Development and Environment (PD&E) Manual, 23, CFR 771, and Section 339.155, F.S., a public hearing will be held.

**Public Hearing Site:** The public hearing will be held at an appropriate facility convenient to the study area.

**Public Advertisement:** An advertisement will appear in the area newspaper with the largest circulation within the area of the recommended alignment (Lakeland Ledger) twice (at least 15 days and no more than 30 days) prior to the public hearing. The advertisements will be sent to the Lakeland Ledger via

e-mail or by registered mail, return receipt requested. In addition, an announcement of the public hearing will be published in the Florida Administrative Register (FAR) at least 7 days prior to the public hearing. The notice will be submitted electronically through the Florida Department of State's e-rulemaking website, [www.flrules.org](http://www.flrules.org), according to its deadlines.

**Letters of Invitation:**

Letters will be mailed to all property owners for two corridors as required by Section 339.155, F.S., and emailed to local elected and appointed government officials notifying them of the upcoming public hearing. Notices may be hand-delivered to residences and businesses located directly along the project corridors as deemed necessary by the FDOT.

**Hearing Preparation:**

Slide presentations and/or video presentations, project corridor aerial maps, graphics, and handouts will be prepared to supplement the oral public hearing presentation.

**Transcript:**

A verbatim transcript of the public hearing will be compiled to include written comments received at the hearing and written comments received within the established comment period after the hearing. All public hearing documentation (handouts, presentation, graphics, etc.) will be included with the transcript. The transcript will include a script of the recorded presentation, if applicable.

**Documents for Public Review:**

All draft documents to support the study evaluation will be available for public review at least 21 calendar days prior to the public hearing date. Public notice will be provided in the public hearing advertisement and by mailed invitational letters as to where the study documents are located for public review, including the physical locations as well as on the project website.

<b>Recommendation Notice:</b>	A legal notice announcing the Office of Environmental Management's (OEM's) approval of the final document and recommendations will be published in the Lakeland Ledger. In addition, press releases detailing the Department's recommendations will be provided to local media. A final newsletter to property owners, as well as an email to local officials will be sent to announce LDCA.
<b>Public Hearing Transcript Package:</b>	A Transcript Package will be produced and submitted following the public hearing. The Transcript Package will include a verbatim hearing transcript prepared by an approved court reporter, an errata sheet detailing any transcript discrepancies, a copy of correspondence received by the Department as part of the public hearing record, and affidavits of publication for newspaper ads advertising the hearing.
<b>Comments and Coordination Report:</b>	A Comments and Coordination Report will be produced and submitted at the conclusion of the study, containing, at a minimum, documentation regarding public participation performed throughout the study period. This report will include comments and responses received from the public, as well as Advance Notification, coordination with local officials and agencies, and public meetings; the verbatim transcript from the public hearing; proof of publication of ads; sign-in sheets; public hearing certification by the Project Manager (Moderator); and public.
