September 2021 — Old Dixie Trail Alternatives Public Workshop

FDOT hosted a virtual and in-person public workshop to present the project alternatives and analysis completed to-date. In total, FDOT received 188 questions and comments on the project. Of the 188 questions/comments, 121 supported Alternative 1 (including a <u>Resolution</u> passed by the City of Auburndale) and 15 supported Alternative 2; the remaining 52 questions/comments were general in nature and did not offer support for either alternative. Coming Soon! 2022 — Old Dixie Trail Public Hearing

Once FDOT makes an informed decision on the preferred alternative, based on feedback received from the alternatives public workshop, a formal Public Hearing will be scheduled for 2022. The Public Hearing will be another opportunity to interact with the project team. The project team will present to the public the preferred alternative and the final analysis. Invitations will be sent out prior to the public hearing to the community stakeholders and residents, so that the public has opportunity to review updated project information and give their input on the proposed improvements. After the Public Hearing, a final decision will be made on the location and conceptual design of the Old Dixie Trail. Once this happens, the PD&E Study is complete, and the project will advance to the next phases of development.
